## SERVICES AVAILABLE

### COUNSELING

Our four Counseling Centers provide outpatient mental health and substance abuse treatment, as well as, a variety of didactic and support groups. Each of the four counseling centers are uniquely different and are designed to meet the needs of the community in which they are located.

### SUBSTANCE ABUSE PREVENTION SERVICES

Presentations, training and consultation services are available to schools, churches and other groups in Northern Macomb County (north of Hall Road). Technical assistance is available in the following areas:

- Developing community programs related to substance abuse issues.
- Community networking and referrals.
- Educational and resource materials.

### SENIOR SUPPORT PROGRAMS

The Senior Homemakers provide assistance to seniors and to assist them in remaining safely in their own homes. Our services are provided by qualified homemakers to Seniors 55 years and older living north of 16 Mile Road in Macomb County. Homemakers cannot perform personal care or provide transportation for the senior.

Macomb Family Services' Senior Volunteer Program provides services to link medically at-risk seniors with health care services within the community. The volunteers provide transportation to: Doctor's Offices, Pharmacies, Hospitals, Medical Supply Stores, Grocery Stores and Shopping Malls.

### SENIOR ADVOCATE PROGRAM

The Senior Advocate provides services to low-income senior citizens 60 years of age or older living in Macomb County. The goal of this Service is to provide the support and assistance needed to promote and secure happier independent and congregate living. Initial needs are assessed and possible provisions are then discussed.

*Federal, State and local funding has been provided through Macomb County Community Mental Health/Office of Substance Abuse to support project costs. Support has also been provided through local Community Development Block Grants, United Way for Southeastern Michigan, Four County Communities Foundation, Shelby Community Foundation, Sterling Heights Community Foundation and private donations.*
